Getting to the DGUV Academy Dresden/Institute for Work and Health (IAG)



By public transport

- from Dresden central station: Tram No. 7 (towards Weixdorf) to the Infineon Nord tramstop (27 minutes)
- from Dresden Neustadt station: Tram No. 3, 6 or 11 to Albertplatz tramstop, then change to tram No. 7 (towards Weixdorf) to Infineon Nord tramstop (20 minutes)
- the DGUV Akademie is very close to Dresden airport: It takes seven minutes by bus 77 (towards busstop Klotzsche Infineon) or 5 minutes by taxi

By car (motorway A4)

Take the Dresden exit Flughafen/Wilschdorf. Turn right (towards Klotzsche) into Hermann-Reichelt-Straße. After 1.3 km, turn right at the traffic lights (Flughafenstraße/Karl-Marx-Straße), and after another 1.3 km, turn right again (Königsbrücker Landstraße). After 300 m, turn left at the traffic lights (sign post „DGUV Akademie“ at the left).
